



## HIRE AGREEMENT AND OPERATING INSTRUCTIONS FOR PILBARA PARTY HIRE BOUNCY CASTLES

**PLEASE READ THIS DOCUMENT CAREFULLY. WHEN HIRING AN INFLATABLE, YOU ARE ASSUMING RESPONSIBILITIES SPECIFIED BY LEGAL REGULATIONS. YOU MUST SATISFY YOURSELF THAT YOU UNDERSTAND AND CAN COMPLY WITH THIS AGREEMENT AND INSTRUCTIONS.**

### HIRE AGREEMENT

OPERATION of the inflatable is handed over to the hirer by the owner when set up is complete unless agreed otherwise. The hirer shall provide a supervisor aged 18 years or over. See terms of supervisor under Safety Guidelines & Important Rules.

**PERIOD OF HIRE:** Period of hire commences when the owner hands control of the inflatable to the hirer OR when the castle is collected from business premises for DIY hire and ceases when equipment is returned to or collected by the owner (Pilbara Party Hire.)

**ONCE THE INFLATABLE IS SET UP BY PPH UNDER NO CIRCUMSTANCES SHOULD THE CASTLE BE MOVED.**

**SOILED/ DAMAGED EQUIPMENT;** The equipment must be returned to Pilbara Party Hire in the same condition it was delivered or received. Any damage to equipment caused by misuse, neglect or loss shall deem the hirer liable for full repair or replacement costs plus the loss of business.

A cleaning charge may be applied to any equipment that is excessively soiled. These charges are at the discretion of the owner and may vary dependant on how soiled the item is. Charges start from \$100.00. Should you receive a soiled inflatable please report it to us so we can rectify the issue.

**RETURNING/COLLECTION OF EQUIPMENT;** The equipment must be returned or made available for collection at the time and date agreed, failure to do so will result in additional charges being levied for each extra hire period. Charges start from \$65/HR, \$150/Day Dependant on item.

### SAFETY GUIDELINES:

**SUPERVISOR;** The hirer shall supply a supervisor aged 18 years or above. That person shall be a responsible person who is capable of exercising control over the children and must not be under the influence of drugs or alcohol. The supervisor must have a **clear** and an **unobstructed** view of the children **at all times** and **MUST NOT leave the inflatable unattended whilst inflated.**

**EVACUATE THE INFLATED CASTLE WHEN WIND GUSTS EXCEED 30KM/HR. REMOVE CHILDREN, DISCONNECT POWER SUPPLY, REMOVE PUMP AND OPEN AIR VALVES TO ALLOW DEFLATION.**

**IMPORTANT RULES FOR DESIGNATED SUPERVISOR:**

- AN ADULT MUST SUPERVISE CHILDREN AT ALL TIMES OF DEFLATION
- TO AVOID INJURIES GRADE CHILDREN BY AGE AND SIZE GIVE EACH GROUP A TURN, DO NOT PUT BIG AND LITTLE KIDS TOGETHER
- DO NOT OPERATE INFALTABLE IN EXTREME WEATHER CONDITIONS; HEAT, RAIN & WIND.
- NO SHOES, JEWELERY, SUN GLASSES, SHARPS, TOYS ETC PERMITTED ON THE CASTLE
- DO NOT ALLOW FOOD OR DRINK AT ANY TIME, CLEANING FEES APPLY.
- NO SMOKING, OPEN FLAMES, BBQS AROUND THE CASTLE AT ANYTIME
- GET CHILDREN TO WIPE SAND AND GRASS OFF THEIR FEET PRIOR TO ENTERING TO ENSURE CLEANLINESS
- DO NOT ALLOW CHILDREN TO CLIMB/ LEAN ON OR RUN INTO WALLSON THE CASTLE. DO NOT PULL ON THE HOOP INSIDE.
- DO NOT ALLOW FIGHTING OR BOISTEROUS BEHAVIOUR
- DO NOT ALLOW ANYONE TO SIT OR PLAY ON THE STEP/ ENTRANCE. SIT AND SLIDE OFF WHEN EXITING. NO JUMPING OFF OF STEP.
- DO NOT ALLOW CHILDREN ACCESS TO THE BLOWER OR POWER SUPPLY
- DO NOT ALLOW PETS ON OR NEAR THE INFLATABLE AT ANY TIME
- CHECK ANCHORS FOR SECURITY REGULARLY
- NO FLIPS OR TRICKS PERMITTED TO PREVENT/ MINIMISE INJURY

**USE OF SLIDE IF EQUIPPED:**

- ONE USER AT A TIME
- SLIDE ON BACK ONLY WITH ARMS TUCKED IN

**MAXIMUM CHILDREN AT ANY ONE TIME:**

**TROPICAL ISLAND:** 10- 12 CHILDREN

**SPONGEBOB:** 8-10 CHILDREN

**DORA & DIEGO:** 8-10 CHILDREN

**PLAYTON OBSTACLE:** 3 CHILDREN
